### From the Rector

This marked another year of growth in grace for us at St Thomas as we continued to live into the mission and ministry called forth in our new strategic plan, *St Thomas: A Transforming Community*. Our outreach ministries remained strong as we prepared and served over 1200 meals to hungry Eastside families at Thanksgiving and welcomed 38 men experiencing homelessness to be in residence with us for the month of July though Congregations for the Homeless. We also welcomed and supported a wonderful family from Rwanda, the Ndayisengas, who are seeking asylum in the United States. We also continued our ministries to our Palestinian Christian sisters and brothers including a visit to them by a group of St Thomas pilgrims who made their way to the Holy Land in March.

We said good bye to our dear friend, Charles Rus who for so many years had served with distinction as the Associate of Music and Liturgical Arts. We were delighted, at the same time, to welcome Doug Cleveland in that role. Doug is an internationally known organ performer who is also on the Music faculty at the University of Washington. Under Doug's leadership, our choir has experienced significant growth and their leadership in our worship is a great gift Sunday by Sunday.

This marks the second year of our Year-round Stewardship program, *Living in Faith, Generosity and Community*. Together, as individuals, families, and a community of faith, we have engaged in an ongoing conversation about stewardship. While that conversation includes a request for each of us to make an annual commitment of financial resources, being intentional and prayerful throughout the year about stewarding our time, our skills and callings, and our money draws us closer to the Living Source of all we are. One result of this fresh approach has been a record setting pledge commitment for 2017 in the amount of \$1,110,161, with an average pledge of \$4,270. This represents a 14% increase over 2016 and is cause for great thanksgiving. This is a remarkably faithful and committed community.

Another piece of great news is that we have received a gift from a very faithful family which will allow us to retire the remaining debt on the Ebsworth Life Center. After deducting the outstanding collectible pledges and accounting for the payment due on work on All Soul's Chapel (the indoor columbarium), this extraordinary gift will pay off the final balance due on the mortgage of \$310,000. We give thanks to God for the generous and committed hearts of these long-time members of the St Thomas community!

On a personal note, this year brought a significant and unexpected health challenge to me when I was diagnosed with throat cancer. I was blessed to come under the care of talented health care professional at the University of Washington/Fred Hutch Cancer Research Center and Group Health. Following a major surgical procedure and radiation therapy, I am grateful to report that I am cancer -free and am expecting a complete recovery. The prayers and the love of this community were without a doubt at the heart of this successful outcome. You sustained me in ways large and small and I will be forever grateful for your love and compassion for me and for my family. I saw the face of Christ in so many of you during this difficult time.

The document you are holding describes major ministry and administrative initiatives undertaken by the parish in 2016 and you will note the significant and increased level of activity. It speaks to health and growth and new life and, yes, change. God is always leading us forward. Something new is being born here. God's *ruach*, God's holy breath, is bringing change which means new life. Yet our Tradition remain strong. The great church historian, Jaroslav Pelikan once said the "Tradition' is the living faith of the dead, while 'traditionalism' is the dead faith of the living." We stand on the shoulders of the faithful ones who have gone before us and who have left a strong foundation for us. We stand on our Tradition. Our charge is to continue to build on that legacy for the next generation. We are doing that with faith and energy. We are allowing the Holy Spirit to transform us.

### Minutes of the 2017 Parish Annual Meeting

- 1. <u>Opening Prayer</u> The meeting was opened with prayer by Rector Lex Breckinridge at 12:05 pm.
- 2. <u>Call to Order</u> The meeting was called to order at 12:08PM on February 26, 2017 by the Senior Warden, Bill McSherry.
- 3. <u>Approval of 2016 Minutes</u> There was a motion that was seconded to approve the minutes from the 2016 Annual Parish meeting. The motion carried.
- 4. <u>Rector's Address</u> Rector Lex Breckinridge asked parishioners to read his letter published on page 3 of the 2016 Year in Review document that was handed out at the meeting. In addition, he announced the receipt of an extraordinary gift from Fred & Mike Hayes of \$310,000 to retire the outstanding debt on the Ebsworth Life Center. Father Lex also thanked the congregation for the gift of love and compassion during the past year with his cancer diagnosis, and he announced that he is now cancer-free.
- 5. <u>Senior Warden's Comments</u> Senior Warden Bill McSherry indicated this was his second time as Senior Warden. Four years ago, the last meeting in his prior term was held in the old Great Hall. He stated that we have an unbelievable clergy & staff. He gave thanks to our COO, Greg Murray, for changing the senior warden's job from 20 hours/week to a 20 hours/ month position. He stated that we are in good hands with our volunteer leadership, and that everyone is sacrificially giving in time, talents and treasure.
- 6. <u>2016 Year in Review</u> Key items from Strategic Plan as they relate to the parish vision statement were discussed and described in the annual report.
- 7. Parish Financial Review The Parish Treasurer, Fred Barkman, gave the financial review. The new terminology used for the budget is the Financial Plan for Mission. 2016 was one of our best years financially. We revamped our financial processes to cost accounting with costs spread across programs. Page 21 of the annual report shows the Income Statement. We had a Net Income of \$102,443. There was a big increase in non-pledge contributions and other revenue. Also, we received an unrestricted gift of \$45,000. For expenses, there were changes in wages and facilities. There was a staffing realignment and changes in wages that were not accounted for in the original plan. There was an increase in janitorial expenses as we hired a new service. Also, there were unexpected maintenance costs. We invested in Church Community Builder software, St. Thomas Connect. We will see long-term benefits from this improvement. He reviewed the Consolidated Balance Sheet and Cash Flow Statement and the summary of 2017 Financial Plan for Mission that were published. There are increases in pledging and non-pledging income. The Ebsworth Life Center Debt Service line will disappear thanks to the Hayes gift. There is a change in the diocesan assessment due to a change in the assessment formula from 2-year-look-back to a month-to-month.
- 8. Elections -

Vestry - The slate for the incoming Vestry class 2020 is Lorraine McReynolds, David Paranchych and Kathy Smith. There was motion that was seconded to approve this slate. The motion carried.

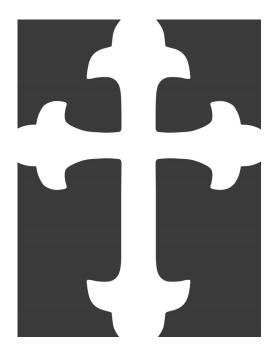

### 2017 Year in Review

### Staff Transitions







After many years of stability in our clergy and staff, 2017 was a year of transition. Part of our mission is to raise up leaders for the broader church, and in 2017, we did just that. 2 members of our staff began new leadership roles in the broader church. Our Associate Rector, Karen Haig, was called to serve as the Rector of Saint Barnabas Episcopal Church on Bainbridge Island, and Brian Gregory, our Associate for Youth, was ordained as a Transitional Deacon and began his curacy at Good Samaritan Episcopal Church in Sammamish. Although these were sad goodbyes, we are thrilled we had a hand in raising up these 2 faithful servants for greater roles in the work of building God's Kingdom.

We also said goodbye to our long-time Deacon, The Rev. Kathryn Ballinger, in 2017. She and her husband bought a new home in the Snoqualmie Valley, and she decided she wanted to serve in a parish closer to their new home.

2017 also saw us walk a tearful journey with Laura Gregg, our long-time Executive Assistant to the Rector. She was diagnosed with cancer during the summer and passed away in September. Laura was filled with such grace in her last months, and she gave the parish a remarkable gift as she helped find and train her replacement, Natalie Ham. Natalie began working with Laura in August. Natalie brings, not only great technical and administrative skills, but a welcoming presence as she stepped into the role of Executive Assistant to the Rector.

To help with the transition during the search processes for a new Senior Associate Priest and Associate for Youth, parishioner Sunni Bannon was hired to serve as the Interim Associate for Youth and Pastoral Care. Sunni has been remarkable in this role and she has brought wisdom, grace, creativity and a real passion for administration to her work with our youth and pastoral care programs.

Regarding the search processes, we hired Ashley Boaeuf to serve as the Associate for Youth in November. Ashley started in this role January. We are thrilled to have Ashley in this role. Her passion for youth ministry and her enthusiasm are contagious.

In November, we also began a national search for the new Senior Associate Priest, and we hope to have a candidate in place by the start of 2018 program year.







### All Things Bright & Beautiful Capital Improvement & Endowment Campaign



In 2016, St. Thomas adopted a strategic plan which included new goals, objectives and strategies to support and promulgate our mission and vision. One of these goals was to "be good and faithful stewards of God's abundant gifts," with an associated objective of "developing and implementing a long-term plan and strategies to preserve, maintain and improve the parish buildings and campus grounds."

Based on this goal and objective, the Facilities Committee prepared an assessment of the earthquake-worthiness of our facilities, the overall condition of our facilities and grounds, our maintenance/repair needs, and developed a scope of work with priorities and costs based on the results of the assessment.

With this information, the Facilities Committee generated a report entitled *Ongoing Maintenance & Capital Improvement Projects*, which was presented to the Vestry, as well as the Finance and Stewardship Committees and the Board of the St. Thomas Legacy Foundation in June of 2016.

These groups concurred with the recommendation that it would be most cost-effective to undertake the other capital repairs and improvements at the time the roof is replaced because of the interdependent nature of the seismic upgrades to the repair of the roof, the repair of north and south masonry walls and related disturbance of the existing asbestos floor tiles, repair of the wood floor framing in the transepts, and installation of a new heating system. They also concluded that the work should be undertaken in 2019 based on an assessment of the remaining useful life of the roof.

From here the Vestry and standing committees unanimously agreed that a study should be conducted to test the feasibility of undertaking a capital campaign to address these needs. The feasibility study was conducted in September 2017, with an overwhelming majority of parishioners voicing their support for the project and campaign.

Based on the results of the Feasibility Study and to ensure that our beautiful church continues to serve generations to come, the Vestry approved launching the All Things Bright and Beautiful Capital Improvements and Endowment Campaign in October of 2017. Kirsten and Bill McSherry and Mary and Fred Williams agreed to serve as co-chairs for the campaign, and James D. Klote & Associates were engaged as our capital campaign consultants.

As of December 31, 2017, we had received 176 pledges totaling more than 3.9 million dollars. In 2018 the Vestry will approve the final scope of work, as well as the total funds to dedicated to the St. Thomas Endowment and support of outreach activities from the total campaign proceeds.

### All Souls Chapel

The All Souls Chapel in the basement of the Ebsworth Life Center was completed in the fall of 2017. This beautiful chapel will serve as not only as a place for prayer and meditation, but as an indoor columbarium. If you have not seen the chapel, you are invited to take the trip down to the basement of the Ebsworth Life Center and visit.



### Youth Vestry Representatives

To encourage the development of our youth through participation through in lay leadership opportunities, the Vestry adopted a resolution in April 2017, which allows for the appointment of up to 2 youth representatives with seat and voice, but no voting eligibility to the Vestry with one-year terms. Stephanie Bentley and Isabel Williams were appointed as the first youth representatives to the Vestry.





### Retreats

In 2017 St. Thomas hosted retreats for our women, men, middle and high school youth, and our families. These times away in beautiful settings provided opportunities for rest, refreshment, and spiritual growth while they deepened bonds in our community.





### Outreach @ St. Thomas

Outreach @ St. Thomas, the new coordination and oversight committee for our outreach activities, continued to support and sustain Congregations for the Homeless, Neighbors in Need, Teen Feed, Sandwich Makers, Giving Tree and Companion Parish, as well as providing financial support for Sophia Way, Episcopal Relief & Development, CROP Walk, Homes for Our Troops, Bellevue Life Spring and others. Total expenditures for all outreach activities in 2017 totaled \$88,586, which equates to 6% of all parish expenses.





### Guatemala Mission Trip

10 high school youth and 5 adults from St. Thomas went to Guatemala for a week in August to work with the Safe Passage, an organization that provides educational opportunities to the children and families that live and work in and around the Guatemala City Dump. Our youth and adults assisted with classroom instruction, supported the installation of a computer lab, learned about the programs of Safe Passage, and developed relationships with the students and volunteers of Safe Passage. This mission trip was our second to Sage Passage.



### Music @ St. Thomas

Under the Leadership of Dr. Doug Cleveland, the music program flourished in 2017. We experienced tremendous enrollment growth in the Adult Choir, and the quality of performances throughout the year, and especially during Christmas and Holy Week, was remarkable. In addition, Doug also instituted Music @ St. Thomas, an annual concert series, which included Choral Evensong events, a concert by famed Westminster Abby organist James O'Donnell, chamber recitals, and a performance of the Sacred Works of Duke Ellington with the Seattle Repertory Jazz Orchestra.

### Administrative Stewardship

During 2017 we continued the important work of stewarding the resources and administration of the parish. Early in the year, we paid off the remaining debt on the Ebsworth Life Center thanks to a generous contribution from Fred and Mike Hayes. In addition the People Resources Committee completed a complete revision of our Employee Handbook and personnel policies. The Finance Committee developed a comprehensive Financial Policies and Procedure Manual, and the Facilities Committee in conjunction with Chief Operating Officer developed an Emergency Preparedness Handbook.



### **Rector Sabbatical Approval**

In March, the Vestry approved a 4-month sabbatical for Father Lex. In addition to being a part of his employment agreement with the church, the sabbatical will provide a time refreshment and renewal after completing 2 capital campaigns. The planned dates for the sabbatical are from mid-April through mid-August in 2018. Interim staffing plans are in place for the sabbatical period.

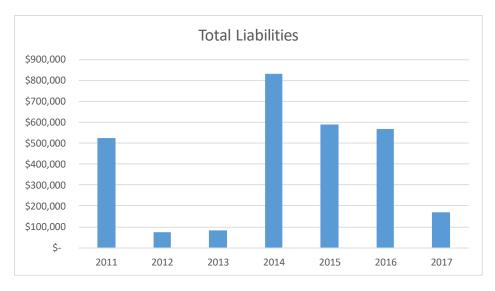

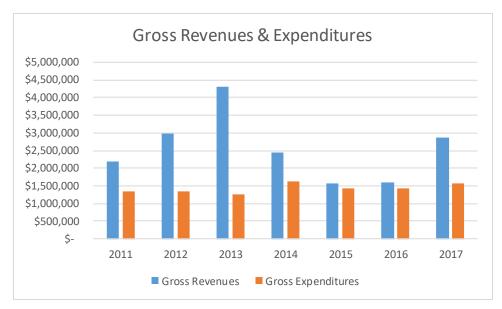

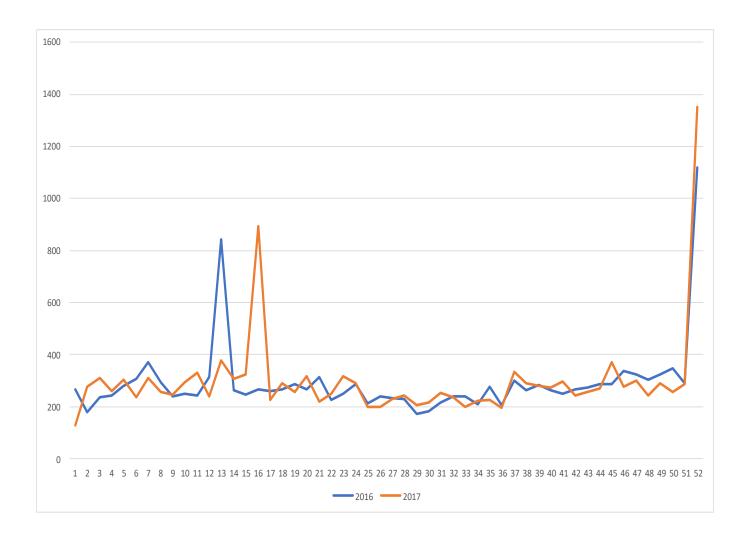

# ST. THOMAS LEGACY FOUNDATION

The St. Thomas Legacy Foundation was established in 2005 and granted nonprofit status in 2007. The Foundation is operated for the benefit of the parish corporation, and it is operated, supervised and controlled by the parish corporation through the Board of Directors of the Foundation as per the by-laws of the Foundation. The Foundation holds, manages and safeguards assets of the parish and supports the parish through encouraging planned and endowment giving. The St. Thomas Legacy Foundation is a Type 1 supporting organization under section 509(a)(3) of the Internal Revenue Code.

### Endowment & Reserve Fund Management & Oversight

The funds under the Foundation's management include the following:

Endowments

St. Thomas Endowment (Perpetual Memorial Reserve & Endowment Fund) Buildings & Grounds Endowment Peggy Behnke Memorial Music Fund Sustaining Fund Columbarium Endowment

Reserve Funds

Outreach Reserve Fund Liturgical Supply Fund Sabbatical Reserve Fund Music Reserve Fund

All of these funds, with the exception of the St. Thomas Reserve Fund and the Music Reserve Fund, which are held in a money market savings account with Wells Fargo Bank, are invested in the Hodges Diocesan Investment Fund (DIF). The DIF was organized in 1951 as a co-mingled fund for the endowment funds of the Diocese of Olympia, its parishes, missions and related institutions. This approach allows small endowment funds to be pooled, thereby providing greater diversification and increased investment opportunity.

The primary objective of the DIF is to build share appreciation over time and to provide a return that significantly exceeds the level of inflation. Another very important objective of the DIF is to provide a high level of income for distribution to congregations and other shareholders to help meet their budgetary needs. The DIF is invested in a diversified portfolio of common stocks and fixed income securities. Since long-term growth of principal is the primary objective, the allocation between stocks and bonds will generally favor stocks. Only parishes and institutions of the Diocese of Olympia can invest in this professionally managed fund that has over \$60,000,000 under management.

### Start-Up Funding for the All Things Bright & Beautiful Campaign

The St. Thomas Legacy Foundation provided funds to the parish to support start up costs for the All Things Bright & Beautiful Campaign in the fall. This funding was invaluable and enabled us to launch of the campaign in October. The funds advanced to the Parish will be returned to the Foundation out of the pledge proceeds.

### 2017 Endowment Distributions to the Parish

The St. Thomas Legacy Foundation's Spending Policy provides a structured approach to the distribution of funds by the Foundation to the parish from its endowments and other fund accounts. The Policy is designed to ensure that the Foundation remains a perpetual and meaningful provider of funds and services to the parish by seeking the preservation of the Foundation's assets on an inflation-adjusted basis.

The Foundation may distribute to the parish up to an annualized 4% of an endowment fund's market value of principal based on a 12-quarter rolling average. The Foundation may also assess up to a 1% administrative contribution on its endowments and other fund accounts to cover the expenses associated with operating the Foundation.
